## **STROYD APPOINTED VICE CHAIR OF BOARD OF CLIENT SECURITY FUND**

**[Pittsburgh Pennsylvania]**, *May 24, 2024* – The Pennsylvania Supreme Court has announced the reappointment of Arthur Stroyd, partner at the boutique litigation firm of Del Sole Cavanaugh Stroyd, to be the Vice Chair of the Board of the Lawyers Fund for Client Security. Stroyd’s reappointment underscores his continued dedication to upholding the integrity of the legal profession and his commitment to serving the community.

Attorney Stroyd brings a wealth of experience and leadership to his role on the Board, having previously served as President of the Allegheny County Bar Association and the Academy of Trial Lawyers. He is also a distinguished Fellow in the American College of Trial Lawyers, an honor bestowed upon only the top 1% of lawyers in Pennsylvania. Additionally, Stroyd was recently honored with the Aradhna Award by Leadership Pittsburgh, Inc., for his visionary leadership and transformative contributions to the Pittsburgh region.

Stroyd’s extensive experience in both legal and community leadership roles uniquely positions him to contribute to the Board’s mission. Throughout his career, he has demonstrated a steadfast commitment to service, having served in numerous professional, charitable and community positions, including as President of the Mt. Lebanon School Board and as a Naval Officer during the Vietnam War.

The Directors of the Pennsylvania Lawyers Fund for Client Security are appointed by the Supreme Court to three-year terms. The Fund is designed to protect the public and maintain confidence in the legal system by reimbursing victims of attorney dishonesty. It is funded by an annual fee from Pennsylvania attorneys, totaling over \$3 million in 2023, and does not involve tax dollars.

“I am honored to be named Vice Chair of the Board of the Lawyers Fund for Client Security,” said Arthur Stroyd. “Preserving the integrity of the legal profession and protecting the interests of clients is of paramount importance, and I look forward to continuing this important work alongside my esteemed colleagues.”

The Board of the Lawyers Fund for Client Security is empowered to award up to \$100,000 per claimant, with an aggregate cap of \$1,000,000 per attorney, though larger amounts may be authorized by the Supreme Court upon request from the Board.
